## 2024 capital gains distribution estimates

The estimated long-term and short-term capital gain distributions for 2024 are listed below. The actual distribution amounts will be based on gains and losses realized through October 31, 2024 (or later, for certain funds). As such, the estimates below may differ from amounts actually distributed in December 2024. Important: Please review the disclosure following the tables for important information regarding anticipated revisions to these reported estimates with respect to a number of SIMT, SIT, and STET Funds.

The funds' long-term approach to investing means that the capital gains realized in a particular year can be the result of an investment held over an extended period of time. The amount of capital gain distributions may vary year over year since the distributions are based on net capital gains realized each year.
